Dear Anne:

Please accept this letter as documentation of my interest in serving on the Community Council for the Nebraska Information Technology Commission.

During the 1990s I worked cooperatively with several entities to host and sponsor training opportunities (computer software; internet navigation, e-commerce, etc.) for a multi-county region before taking a position in York County in September 2001.

One of the first items to be addressed when we reorganized the committee structure of the York County Development Corporation in 2002 was the expansion of the Transportation Committee to include all areas important to the connectivity of a community. As a result, information technology was added as a very important part of this committee's mission (at this time, it is the most important portion).

Last year, the Infrastructure Committee of the York County Development Corporation collaborated with the Mayor's Committee on Information Technology (City of York) to submit a grant proposal to the University of Nebraska's Technologies Across Nebraska (TAN) initiative and Nebraska Information Technology Commission's Community Council mini grant for information technology planning. Our joint committees were awarded funds and currently continue to work through the Community Information Technology Planning and Assessment Workbook to assess the status and needs for our county. Presently, the committee is researching what other communities have done in order to increase the utilization and access to information technology.

To date, our preliminary findings indicate great opportunities for our communities and businesses are available, but for whatever reason these opportunities are not being utilized to their fullest.

As a result of the preliminary findings of the workbook responses, plans for an ecommerce training have been made and several directed workshops for business

and industry are being discussed and researched by the Development Corporation.

The joint committees and the entire York County Development Corporation will be placing increased effort this year in the area of information technology not only in the area of recruitment of new business but also in the arena of existing business.

Information Technology will play a large role in the success of my organization as we seek to retain business and industry and also as we attempt to attract new business to the York County area.

Georgia Masters Keightley

Georgia Masters Keightley was born and raised in Crawford NE. She attended UNL for one year, completed her B.A. (honors) at Trinity College, Washington DC. She received an MA from George Washington University in Washington DC and a Ph.D. from The Catholic University of America, Washington DC. She was a tenured faculty member at Trinity College; her areas of teaching and research included religion and culture, sociology of religion, and women's studies. She served as Chair of the Theology Department and Chair of the Arts and Humanities Division. Dr. Keightley is a member of the American Academy of Religion, the Catholic Theological Society of America, the College Theology Society; she has published widely in academic journals and has been invited to present many scholarly papers both here and abroad; she most recently (November 2001) presented a paper at Leuven University in Belgium. In 1998, Dr. Keightley returned to the Crawford area where she now serves as mayor. She has been active for the past four years in the Crawford Chamber of Commerce, Crawford Vision, and has worked informally to develop the tourist and economic potential on Crawford and the surrounding area. She and two other Crawford residents created the Crawford Information Technology Committee and applied for one of the NITC's mini-grants in fall 2002. With the funds received, they went on to gather data and develop a plan to bring wireless broadband service to the area via an application for a USDA Community Connectivity Grant in November 2002.

In May 2002 Governor Johanns appointed Dr. Keightley to serve on the Nebraska Commission on the Status of Women. As part of this work, she organized a series of workshops, seminars and classes in conjunction with the Women's Business Center of the Center for Rural Affairs for the women of the northern Panhandle area. The Pine Ridge Small Business Association, a local REAP group, was established in Crawford in January 2003; Dr. Keightley is presently working with local banks and businesses to establish a \$25,000 revolving loan fund for the PRSBA. As a member of the Women Under the Law Committee of the NCSW, she is working to organize a series of panel discussions of the legal rights of rural women for the Panhandle district she represents.
